Reappointments

The following individuals have put themselves forward for reappointment to the council:

1. Reappoint Gavin Stewart

In my time on the BFS council I have helped organise in person and online events as well as implementing changes to payment options to streamline processes and make the back-end functioning of the charity more efficient. This, of course, was not without hiccoughs and together with the council I have been working hard to make these transitions as smooth as possible.
